What are the nine performance measures?

The nine performance measures are:

- 1. Chronic absenteeism across the district (target 3% annual decrease)
- 2. ELL students seen at least once annually (not incl. screenings) by the school nurse (target 90% seen)
- 3. Students who are overweight or obese (target 1% annual decrease)
- 4. Students who identified as experiencing depression, anxiety, and/or suicidal ideation to receive mental health services from the school nurse (target 90% receive services)
- 5. Students identified as homeless or marginally housed to receive school nurse services (incl. comprehensive assessment of mental and physical health needs), and referrals and follow-ups, at least twice every school year (target 100% receive services)
- 6. Students with special healthcare needs (asthma, autism, ADHD, diabetes, life-threatening allergies, seizure disorders, diagnosed mental health disorder) to have an Individual Health Care Plan (IHCP) developed (target 100% IHCPs developed)
- 7. Students who fail a screening to have a referral made (target 85% referrals made)
- 8. Students who report having at least one trusted adult at school (target 10% annual increase)
- 9. Students who report having been victims of bullying or violence to receive mental health assessments at least monthly by the school nurse (target 100% receive assessment)

What data sources can be used to assess each performance measure?

In general, DESE data and school district data can be used to assess performance measures.

Possible data sources that can be used to assess each specific performance measure include:

- Absenteeism: DESE attendance data (historical and sorted by student group), and current attendance data from the Student Information System (SIS)
- ELL: electronic health record (EHR) system and SIS
- Overweight/obese: screening records (for students in grades 1, 4, 7, and 10) and EHR system
- Behavioral health: EHR system
- Homeless: EHR system and homeless liaison reports
- Special healthcare needs: EHR system
- Referral: EHR system
- Trusted adult: Youth Risk Behavior Survey (YRBS)
- Bullying: EHR system and bullying records from school administrators

How often are performance measures assessed and reported?

Performance measures are assessed annually at the end of the school year and reported using the status report form (online).

What happens if a performance measure target has not been met?

If a performance measure target has not been met, a plan for improvement must be developed using needs assessment data, a racial equity lens, evidence-based interventions, and quality improvement methods. If multiple targets have not been met, it is recommended that the district select one measure and provide a plan for improvement (selecting a different measure each year).

What are some possible starting strategies for improvement in performance measures?

Possible starting strategies for improvement in performance measures include:

- Absenteeism:
 - Identify absenteeism early in the school year
 - Identify students absent in lower grades (elementary)
 - Target interventions at racial/ethnic subgroups with greatest absenteeism
 - · Create interventions for students with asthma
- ELL:
 - Flag the ELL students in the EHR
 - Query EHR system monthly to identify ELL students not seen
- Overweight/obese:
 - Review evidence-based strategies
 - Focus interventions on subgroups (i.e., race/ethnicity, socioeconomic status) with the greatest percentage of obese/overweight students
 - School meal and food policies
 - Increase opportunities for daily physical activity
- Behavioral health:
 - Use the EHR to track students with mental health issues
 - Improve outreach, especially to subgroups disproportionally impacted
- Homeless:
 - Track all data elements in EHR system
 - Query EHR system to identify students for follow up
- Special healthcare needs:
 - Run a monthly query of students with special healthcare needs without IHCPs
 - Identify missing IHCPs by race/ethnicity subgroups
- Referral:
 - Improve the referral tracking and follow up system
 - Use EHR to track referrals and completed referrals
 - Run a monthly query of students who fail a screening but don't have a referral;
 - Check for disparities by race/ethnicity
- Trusted adult:
 - Use "warm" handoffs for referrals
 - Work with school partners to implement school-wide SEL strategies that emphasize connections to school community
- Bullying:
 - Identify victims and victim subgroups
 - Schedule monthly mental health assessments

What resources are available to schools for reporting performance measures assessments?
